WHAT DO I GET?

HOW DOES IT WORK?

 - *Must include promo code BEAST-TRADEIN-US as a line item with the SATABeast controller's serial number(s) in the description field. Serial number is found on the backs of controller.*
2. **Reseller emails NexsanRMA@imation.com to get RMA number for the SATABeast controller(s).**
 - *Must include the purchase order number and promo code BEAST-TRADEIN-US.*
3. **Customer/Reseller ships the SATABeast controller(s) and Certificate of Destruction to Nexsan (Thousand Oaks).**
 - *Must occur within six weeks of receiving the new E-Series system.*
 - *Only the controllers are needed. Please destroy the SATABeast and include a Certificate of Destruction.*
4. **Reseller receives credit within 14 business days of Nexsan receiving controller(s) and Certificate of Destruction.**

THINGS TO KNOW.

- SATABeast trade-in rebate promotion is only available with the purchase of fully-populated E18V, E48V, E48VT, E60V, and E60VT systems with 3, 4, and 6TB drives (not available on XV models).
- Maximum of one SATABeast systems (\$2,400 value each) with purchase of one E18V system.
- Maximum of two SATABeast systems (\$3,000 value each) with purchase of one E48V, E48VT, E60, or E60VT system.
- No limit to the number of E18, E48, and E60 units that can be purchased under this promotion.
- Purchase order must be received by Nexsan in time for shipment by December 31, 2015.
