## PRIZE CONNECTION PROGRAM RULES AND GUIDELINES

### WHO'S ELIGIBLE?

- Any Panasonic authorized reseller enrolled in the Authorized Reseller program who is Tier C or higher and has been issued a PNA ID can participate in Panasonic Prize Connection.
- You must be employed as a sales rep for an authorized PSCNA reseller and be an employee in good standing.
- Distributors are not eligible to participate.
- You must be registered to participate online in Panasonic Prize Connection to earn program rewards.
- All eligible sales must be entered online by the reseller owner/manager or designated administrator who at his/her discretion will distribute the
  points earned accordingly.
- Sales claims prior to your date of registration do not qualify.
- Debit cards are issued when the 250-point threshold is met by program participants, January 1, 2015, to December 31, 2016. If you have a debit card from the previous program year, points for claims entered in 2015 will be applied to your debit card once you meet the 250 point threshold.

#### WHAT'S ELIGIBLE?

- New qualifying units sold and installed in end-user (3rd party) locations between February 15, 2015, and March 31, 2016, are eligible for Panasonic Prize Connection awards.
- Only models listed on the Eligible Products page for the February 1, 2015, through March 31, 2016, promotional period are eligible for reward.
- Models placed on trial or for demo are not eligible until actually sold and invoiced. Only new products qualify for awards.
- Only selling reseller locations are eligible for rewards. Install-only reseller locations DO NOT qualify for program awards.
- Only product(s) purchased from PSCNA authorized distributors are eligible to claim Panasonic Prize Connection rewards.
- Claims are subject to audit, verification and validation.

### TIME FRAME AND GUIDELINES FOR REPORTING SALES:

- Do not report your sale until your customer is invoiced.
- You must be employed as a sales representative/selling sales manager at an authorized PSCNA office and be an employee in good standing.
- Sales must be reported within 60 days of the invoice date. Point values in effect on the invoice date will be used for rewards.
- You must be an authorized PSCNA reseller to participate online in Panasonic Prize Connection to earn program rewards.
- A copy of the computer-generated invoice supporting the sale(s) must be received at Program Award Headquarters within 60 days of the date you report your sale on the website. Invoices received after this 60-day period will not be accepted, and sale(s) will be denied. Sales agreements, quotations, purchase orders, delivery tickets, etc., will not be accepted as proof of sale.
- All claims for sales during the January 1, 2015, through December 31, 2016, program promotional period and backup documentation must be received no later than February 14, 2016.
- All points earned in the calendar year 2015 must be redeemed by Friday, March 11, 2016. Any unspent points will be removed from the card on Monday, March 14, 2016.
- You must maintain a set of records with the customer invoices for each unit claimed in the event we need you to resubmit your proof of sale for any reason. We suggest you save a copy of the fax verification sheet in the event that we cannot find your proof of sale and need to verify the date you originally sent it.
