PROCESS

- 1. Complete the Demonstration Unit Purchase Program Form.
- 2. Send form to Reseller Support ResellerSupport@us.panasonic.com
- 3. Panasonic will respond to requests within 48 hours (2 business days).
- 4. Once the approved Demo ID number is issued, it is the responsibility of the reseller to place the order with the designated distributor.
- Approved Demo Purchase Special Pricing Letters (SPLs) have an expiration date 30 days from the date the SPL is sent to the designated distributor. The expiration date will be clearly stated in the confirmation email sent to the reseller. Please be sure to purchase requested demo units prior to the expiration date.

TERMS & CONDITIONS

- This is a purchase program; once bought, units cannot be returned to distribution or to Panasonic.
- Only current Panasonic products can be ordered as demo units. Channel limited and discontinued products are not eligible.
- Accessories are not eligible for the demo unit program.
- If requesting multiple units of a Projector, Professional Display of Professional Video SKU, the form must include each selling location's address.
- Units are to be available for end-user demonstration purposes at the reseller location for a minimum of 90 days from receipt of the unit. Panasonic reserves the right to audit reseller locations regarding demo unit stock.
- After the 90-day minimum demonstration period the product may be resold; however, reseller must maintain demonstration unit commitments as required by the reseller program guidelines.
